The following is documentation of the idea and proposed wording for the **Constitution Rights Tags**.

## **Idea Description (Originally Posted 5/2/08)**

**This idea has been created and developed by NFPCAR (National Foster Parent Coalition for Allegation Reform)** which is non profit online support group for families who have been falsely attacked by CPS or the Juvenile Justice System. Our support group has developed the idea of the "Miranda Dog Tags" as a "safe-guard" for children that will protect them from being forced to talk to "**strangers**" who try to interview and or interrogate them without the parents and/or their attorney's being notified or present. On one side of the tag would have personal contact information for their parents and their attorneys and the other side would have a brief "Constitution Awareness" statement for the child to use when needed. These Dog Tags can be worn by any child and presented when cornered by strangers. Directions for proper use will be included.

This idea is meant for **ALL** parents...children...biological, foster, adoptive or kinship care. We at NFPCAR totally **AGREE** that the common enemy is **CHILD PROTECTION SERVICES**...(CPS) and we **ALL** need to stand together in this fight. As soon as we can get these "dog tags" manufactured and on the market they will be offered to "anyone"...not just foster families.
